In order to purchase from Cheney Brothers, a new account form must be filled out completely, including but not limited to:

- Complete Legal and trade name and address, phone, and email.
- Owner, Director, or Management name, home address, home phone, date of birth, Social Security (US residence), and copy of passport.
- Name and signature of person submitting the passport after PAYMENT TERMS.
- The Florida Department of Revenue must be signed to avoid Sales tax

If customer is requesting credit terms, credit terms will be considered upon receipt of the following:

- In order to receive credit terms, the personal guarantee must be signed by person submitting the passport in the new account application form.
- Credit terms will be given upon receipt of Letter of Credit from Bank for the amount of credit desired. Letter of Credit must come from a qualified bank and worded with instructions as shown in the Letter of Credit Instructions.
- Credit terms will be considered upon receipt of a copy of three invoices from different suppliers within the United States from the last 60 days, showing the credit terms received and the total amount of the invoice.

TERMS AND CONDITIONS

PAYMENT TERMS

Parties hereby agree that all purchases made are subject to the following terms and conditions:

- 1. The undersigned purchaser hereby agrees that all amounts due for goods and services purchased from Cheney Brothers, Inc. are payable at the address shown on the invoice and statement.
- 2. The undersigned purchaser hereby agrees that all amounts due Cheney Brothers, Inc. are payable 7 days from the date of statement. If any amount due Cheney Brothers, Inc. is not paid within said period, a delinquency charge in the amount of 1 1/2% per month on the unpaid balance, as governed by the State of Florida, shall be added to the total amount due.
- 3. The undersigned purchaser agrees to pay Cheney Brothers, Inc. a service charge of the greater amount of \$40.00 or 5% of the check balance for all protested checks returned by their bank. Purchaser further agrees to pay the above service charges plus three times the amount of the face value of the check, all attorneys' fees and costs, and any other amounts authorized by law should account be referred to a collection agency or an attorney for collection.
- 4. The undersigned purchaser agrees to pay in accordance herewith. In the event that a guarantee is executed, then all so executing shall be jointly and severally liable with each other and the purchaser and relevant words herein shall be read as if referring to the plural.
- 5. The parties hereby acknowledge that the goods and/or services purchased from Cheney Brothers, Inc. are not payable in installments, but are payable in full as stated herein. Ownership of the goods and services does not transfer to purchaser until paid in full. At anytime prior thereto, Cheney Brothers, Inc. reserves the right to confiscate such goods or cease such services in the event purchaser fails to meet its payment obligations.
- 6. The undersigned hereby authorizes you to verify the information on this form, which is being requested by Cheney Brothers, Inc. to establish credit with their company. Specific Authorization is given to both the bank and trade references listed to disclose all account information for the specified accounts. Cheney Brothers, Inc. is further authorized to conduct a credit check through Equifax or other credit-reporting agency on the purchaser and each individual officer, owners, partner or proprietor identified herein. Each such individual/party agrees to submit a copy of his/her driver's license, passport and/or photo ID as identification for this purpose. This form may be transmitted to any of the parties noted as proof of authorization.
- 7. If purchase or payment is permitted to made by credit card (requires separate authorization and form), purchaser/cardholder waives all right to dispute or protest any and all such charges with its credit card company or bank. Charges, once made, are final and may only be disputed directly with Cheney Brothers, Inc.
- 8. Purchaser and guarantor (if applicable) agree to provide supplemental credit information upon request.
- 9. In the event payment is late by thirty (30) days or more, Cheney Brothers, Inc. may immediately obtain a final consent judgment against undersigned purchaser and Guarantor (hereinafter collectively "Debtors") for all monies due plus attorneys' fees and costs. The final consent judgment, at Cheney Brothers, Inc.'s sole discretion, may be obtained against any one, all, or a combination of the Debtors, individually or jointly and severally. Debtors agree that the final consent judgment attaches to and serves as a lien on all real and personal property of Debtors without limitation.
- 10. The parties agree that jurisdiction and venue for entry of the final consent judgment, enforcement of this Agreement, and any related legal action shall be in the state courts in Palm Beach County, Florida, USA. Any dispute shall be governed by Florida law. The parties further agree that valid service of process or any other papers may be obtained via mail or through the Florida Secretary of State. The parties further agree that any judgment against Debtors may be executed upon, enforced, and/or recorded, at Cheney Brothers, Inc's sole option, in any venue where Debtors have assets or property. Debtors agree that any and all judgments against them obtained hereunder attach and serve as liens on all real and personal property of the Debtors without limitation.

The undersigned hereby agrees that payment terms are as specified on invoice unless otherwise agreed by the parties and memorialized in writing. LETTER OF CREDITS

For those customers that want credit, then the customer can get credit terms by offering security in the form of a letter of credit from a bank. Then we will give them credit terms.
